HOMICIDE INVESTIGATION, VICTIM THOMAS SMITH, III (AGE 20) STATE V. JEQUISE R. FORREST STATE V. ALONZO E. MINCEY STATE V. JERRAMIAH MICHAEL

<u>UPDATE 8/18/25</u>; At approximately 12:20 pm all three defendants (Forrest, Mincey and Michael) were apprehended at an apartment located in the Amity Heights apartment complex in Bridgeton, NJ by personnel from the Millville Police Department and the Cumberland County Prosecutor's Office with the assistance of the Bridgeton Police Department and the New Jersey State Police Fugitive Unit.

Correction: Event occurred on Friday, August 15, 2025.

The Cumberland County Prosecutor's Office and the Millville Police Department are investigating a homicide that occurred on Friday, August 15, 2025, at approximately 6:53 P.M.. On that date, the Millville Police Department responded to the area of High & Oak Streets in Millville for a male individual suffering from a gunshot wound to the head. It was later learned that the victim, who was identified as Thomas Smith, III (age 20), was shot and succumbed to his injuries shortly thereafter.

Investigators were able to identify three individuals involved in the shooting death of Smith. As a result of the investigation, the following individuals were criminally charged for the murder of Thomas Smith, III:

Jequise R. Forrest (age 19) of Green St., Millville.

The investigation remains ongoing. Despite ongoing efforts to locate Forrest, Mincey and Michael, they remain at large and should be considered armed and dangerous.
