ROBBERY:

On 11/8/2024 at approximately 2036 hours, officers responded to the 100 Block of S. Burlington Road for a report of a robbery. Upon arrival, the victim stated he was approached by an unknown black male who struck him with a baseball bat and demanded he turn over his wallet. After the subject took the items, he fled the scene on foot. No further description was provided. The victim was transported to Inspira Hospital of Vineland and treated for non-life-threatening injuries.
